**RULES**

1. Young Man & Young Woman of the Year Award will be presented for achievements, leadership, and service to the community during calendar year 2018. The overall impact of community service achieved by the nominee will be a significant factor in the nomination review. The award is for direct, outstanding service and has no relation to Jaycee membership. Nominee need not be a member of the Gainesville Jaycees.
2. Only young men and women 40 years of age or younger are eligible. If the nominee reaches his or her 41<sup>st</sup> birthday before December 31, 2018, he or she is eligible if the activities were performed before their 41<sup>st</sup> birthday.
3. The nominee must have resided in Hall County during the 2018 calendar year.
4. All nominations must be postmarked no later than December 16th, 2018.
